Wed., 8/3/2022

- Talks on artificial intelligence applications by Lloyd Hilldebrand, Jeff Henderer and Jim Tsai. Changing paradigms in retinal screenings in PCP and ophtho offices.

- Rob Melendez and Arvind Saini talked about advances in improving results from cataract surgery including best practices for IOL measurements and light adjustable IOLs.
- Charles Cole and Cynthia Chiu discussed the Yamane technique for scleral fixated IOLs without sutures.
- Derek Delmonte discussed tips for recruiting successful team members in private practice.

- Chris Albanis and David Epley dressed in Mickey Mouse attire to give a talk on how to incorporate Disney practices into our medical practices. Sprinkle that pixie dust!
- Jinali Diora discussed learning lessons that occur as an early attending MD

- Leela Raju presented an update on the Eye Foundation of America. Leela's father was one of the founding members of this mission which began in 1977.
- Faruk Orge gave an update on IPOSC an international peds collaboration. Faruk is the current president of this society and their work is broad and wide reaching.
- David Plager reviewed 50 year experience with pediatric IOLs.
- Sohail Hasan reviewed the history of the pinhole. He has now been nicknamed Sohail "Pinhole" Hasan.
- Steven Couch reviewed a new technique for combined orbital decompression and simultaneous strabismus surgery for thyroid eye disease. This was presented as part of our "Free-for-all" session
- Christopher Estopinal discussed taking care of uninsured patients in Virginia and further health insurance access in the US. He discussed a program called Access Now which is available in many areas to provide care for uninsured patients.
- Glen Hoar reviewed the difficulty in adequately communicating to patients for true understanding of the patients.
- Erich Horn presented implications of covid-19 surgical layoff and how it relates to complication rates. Erich's study looked at IRIS registry data and did not find a significant increase in complication rate post hiatus.
- Gary Lelli discussed private equity acquisition in ophthalmology and healthcare.
- Purnima Patel, Sonny Goel and Rob Melendez discussed starting solo ophthalmology practices.
- Stephen Mcleod discussed equity within ophthalmology. This was given as the 18th Jerry and Donna Knauer AESC Foundation lecture.

Sat., 8/6/2022

- Adam Reynolds presented the eye as art. He showed how pictures and OCT images of the retina and optic nerve are artistic and he shared his artwork of these structures.
- Jess Berry reviewed her basic and translational research on treatment of retinoblastoma and the results of genetic testing of the vitreous in these patients.
- Aleksandra Rachitskaya reviewed novel surgical approaches in the field of retina.

- Shree Kurup reviewed intravitreal injection flow dynamics. Treatments of these injections were performed in the suprachoroidal space. There is scalability to this technique to target long acting drugs and for glaucoma.
- Matt Cunningham reviewed vitrectomy for macular holes.
- Curtis Hagedorn discussed vitrectomy, laser and gas for young phakic primary retinal detachment. When polling the retina specialists in the room, many preferred scleral buckling to vitrectomy in these cases. Curtis made the case for primary vitrectomy in these cases.
- Keith Baratz talked about corneal endothelial replacement. Visual acuities were better after DMEK compared to DSEK.
- Nick Bell reviewed the results of the ASSISTS trial.
